

NAPI TERMS OF SERVICE

1. Introduction

Welcome to Napi, a platform that provides an easy REST API for accessing data from your Notion workspace, along with a web application for managing your projects in a structured and efficient way.

Napi is designed for developers, teams, and makers who use Notion to manage content or structured data (such as blogs or product catalogs) and want to make that data available through a clean, customizable API. With Napi, you can connect your Notion workspace, automatically generate an API for your content, and manage multiple projects through a simple web interface.

By accessing or using the Napi service (“Service”), you agree to be bound by these Terms of Service (“Terms”). If you do not agree with these Terms, you must not use the Service.

The Service is operated by Vojtěch Habeš, a self-employed individual registered in the Czech Republic, IČO: 23492082, with a registered office at Fibichova 1272, 271 01 Nové Strašecí.

These Terms are effective as of 29. 7. 2025.

2. Eligibility

To use the Service, you must be at least 18 years old and have the legal capacity to enter into binding contracts under applicable law. By using Napi, you represent and warrant that you meet these requirements.

Use of the Service is not permitted where prohibited by law.

3. Account registration and security

To access certain features of the Service, you may need to create an account. You agree to provide accurate, current, and complete information during the registration process and to keep your account information up to date.

You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. If you suspect any unauthorized access or misuse of your account, you must notify us immediately.

Each individual or entity may register only one account. We reserve the right to suspend or terminate accounts that violate this rule or are found to contain false or misleading information.

If you wish to delete your account, please contact us directly using the contact information provided in Section 12.

4. Description of the service

4.1 Service overview

Napi offers a Notion integration that connects to your workspaces. It automatically generates a content REST API that allows easy access to your Notion databases.

It consists of "projects" that correspond to one Notion integration connection – you may create multiple projects by linking different workspaces or Notion accounts.

4.2 Features

- A REST API for accessing content inside databases in your linked Notion workspace(s).
- A web application UI to browse, organize, and manage projects.
- Support for multiple projects per user, each tied to a specific workspace connection.

4.3 Third-party dependencies & uptime

Napi relies on external services including Notion (for data access), Firebase (for hosting/storage), and Stripe (for payments). We are not affiliated with any of these providers. Service interruptions, API changes, or outages affecting third-party platforms are beyond our control, and we accept no responsibility for any resulting disruptions.

4.4 Limitations & fair-use guidelines

- The Notion API enforces a rate limit of approximately 3 requests per second, with occasional bursts allowed. Our caching layer may allow higher effective throughput in some cases.
- Napi does not impose additional usage caps; however, usage remains subject to the limitations of Notion's API.

5. Usage restrictions

When using Napi, you agree not to:

- Engage in unlawful or immoral activities

Use the Service for any purpose that violates applicable law or regulation, including fraud, money-laundering, or facilitating criminal activity.

- Send spam or unsolicited messages

Transmit spam, bulk messages, chain letters, or any unsolicited communications through the Service.

- Reverse engineer or scrape

Decompile, disassemble, reverse engineer, or otherwise attempt to derive source code, APIs, or underlying structure of the Service or Notion API beyond what is publicly documented.

- Impersonate any person or entity

Pretend to be another individual, company, or service in a way that misleads others or violates another's rights.

- Overload or attack the system

Conduct denial-of-service attacks, flooding, or any activity that disrupts or degrades the performance of the Service or Notion's API.

- Exploit bugs or security vulnerabilities

Intentionally abuse or work around known or suspected bugs, vulnerabilities, or limitations in the Service.

Violation of any of these restrictions may result in immediate suspension or termination of your account, at our sole discretion.

6. Payments and subscriptions

6.1 Trial Period

When you sign up for a paid plan, you are eligible for a 7-day free trial ("Trial"), which begins once valid payment details are provided.

You must provide valid payment information at the billing setup to activate the Trial.

If you do not cancel before the Trial ends, your subscription will automatically convert to a paid plan on the day following the Trial's expiration.

6.2 Plans & Pricing

- Monthly Plan: \$2.40 per project per month
- Yearly Plan: \$21.60 per project per year (billed annually)

6.3 Billing

- All billing is processed via Stripe.
- Subscriptions renew automatically at the end of each billing cycle unless you cancel beforehand.
- You are responsible for maintaining accurate payment information. Failed payments may result in suspension or termination of your access.

6.4 Cancellations & Refunds

- You may cancel your subscription at any time from your dashboard on our Service.
- No refunds or credits are provided for partial periods or unused service time.
- Cancellation takes effect at the end of the current billing period; you will not be charged thereafter.

6.5 Price Changes

- We reserve the right to change pricing or billing policies at any time.
- We will provide notice of any material price increases via email or in-app notification at least 30 days before they take effect.

7. Intellectual Property

All software, code, designs, graphics, trademarks, logos, and other materials used to provide the Service (collectively, the “Napi Technology”) are and will remain the exclusive property of Vojtěch Habeš (operating as Napi) or its licensors. No ownership rights are transferred to you under these Terms.

You retain all ownership rights in the content you store, create, or manage through your Notion workspace (“Your Content”). Napi does not claim any ownership in Your Content.

By using the Service, you grant Napi a limited, non-exclusive, royalty-free, worldwide license to access, retrieve, and display Your Content solely for the purpose of providing and improving the Service.

If you provide suggestions or feedback regarding the Service (“Feedback”), you grant Napi a perpetual, irrevocable, worldwide, royalty-free, fully transferable license to use and incorporate such Feedback into the Service or other products without restriction or compensation to you.

8. Termination

We may suspend or terminate your account, access to the Service, or this Agreement at any time and for any reason, including but not limited to:

- Your breach of these Terms.
- Fraudulent, immoral, or illegal activity.
- Non-payment of fees.
- At our sole discretion, for any other reason or no reason at all.

Termination takes effect immediately upon notice to you (which may be by email or in-app notification).

Upon termination or expiration of your account:

- Your access to the Service and Your Content will be disabled.
- We may permanently delete all Your Content in our systems after a reasonable retention period.
- All outstanding fees and charges remain due and payable.

9. Disclaimers

The Napi Service is provided “as is” and “as available”, without warranties of any kind, express or implied. You use the Service at your own risk. To the fullest extent permitted by law, we disclaim all warranties, including but not limited to merchantability, fitness for a particular purpose, availability, security, and non-infringement.

We make no guarantees regarding the uninterrupted, error-free, or secure operation of the Service or any aspect of it. We are not responsible for any loss of data, business interruption, or other damages that may result from your use of the Service. Our liability is limited to the maximum extent permitted by applicable law, and in no event will we be liable for any indirect, incidental, special, or consequential damages.

By agreeing to these Terms, you acknowledge that no oral or written advice given by us or our representatives will create any warranty or liability not expressly stated here.

Our total liability to you for any claims arising out of or relating to the Service is limited to the amount you paid us in the 12 months preceding the event giving rise to the claim.

10. Changes to the terms

We reserve the right to update or modify these Terms of Service at any time. When we make material changes, we will notify you by email or through the Service prior to the changes taking effect. Your continued use of Napi after such notification constitutes your acceptance of the updated Terms.

It is your responsibility to review the Terms periodically to stay informed of any changes. If you do not agree to the updated Terms, you must stop using the Service and cancel your account.

11. Governing law

These Terms of Service and your use of Napi are governed by and construed in accordance with the laws of the Czech Republic, without regard to its conflict of law principles.
